Competition Details

Young Enterprise is launching a Competition to enable 6 Young Enterprise NI Alumni to travel and stay in NEW YORK CITY for a full week in June 2019, to experience the US culture of entrepreneurship. The initiative will include local and international visits to start up and incubator spaces as well as providing exciting opportunities to connect young people to an established network of Entrepreneurs in Northern Ireland and New York.

The Competition will include a number of activities in NYC from 14 June to 22 June with flights and accommodation included.

How to Apply

An invitation to apply for this initiative will be open to our Young Enterprise Alumni aged 18-25. All applicants will be required to submit a short video up to 60 seconds based briefly on your experience of Young Enterprise, but more importantly where you are at present in terms of your business journey and what would you do with the support to either develop your existing business or new business idea.

Submissions will be shortlisted on the 29 March 2019 and successful applicants will be invited to attend a pitch and interview to discuss their idea to a Dragon's Den style panel of independent panel of judges on 15 April 2019. The panel will want to understand more about your business and your plans over the next 18 months and explore how you would make the most of the opportunity with connections in New York.
